YCOE Board Update

February 28, 2017

Early Childhood Education Program Highlights

- **ECE Literacy program**, with support from KVIE, was able to provide 4 workshops for our families. The workshop titles were: TV As A Learning Tool, Math Is Everywhere, and Healthy Habits. These workshops were offered in various sites in West Sacramento and Woodland. One hundred families attended the training. The trainings were delivered in English and Spanish, child care was provided and each family receive a book for attending.
- Families participated in Cardboard Creations. The children were investigating the topic of Reduce, Reuse and Recycle. The culminating family event was for the children to build a robot at home with their family and bring it into school to share.
- Collaboration project with *ExplorIt*, YCOE and ECE program continues in full force. The children have been offered exciting activities around the topic of Ramps. They have been learning new vocabulary words such as; slope, elevation, speed, hypothesis, force, design, cause and effect.

Special Education

- Student Transition Symposium held at YCOE on February 27 approximately 100 students that receive special education services in Yolo participated including: YCOE students from Davis Senior High Horizon, Woodland High School Horizon, and the two ALS classes participated in sessions on supported living, getting a job, colleges, and so much more.
- Arts/Music: Our YCOE special education Classes have a variety of activities that they are participating in such as:
 - o Greengate had the Blues in the School in February
 - Greengate; Whitehead Horizon elementary classes; and the ALS classes have been participating in a Music Therapist leading the classes in musical exploration/lessons/etc.
- Upcoming events Saturday, March 18th will be the NorCal Trykers bike build day; Saturday,
 March 25th will be the Bike give away at Greengate for our ten students/families that have bikes being donated to them
 - Yolo Arts is scheduled to provide lessons in all of our classes with topics such as ceramics; 2 dimensional art; and a variety of other art activities to our classes

Curriculum, Instruction & Student Services

Students at Chavez – West Sacramento have been participating in an "Energy & Electronics
 Academy" – weekly hands-on career exploration/experience sessions facilitated by Krista
 Purdom, Educational Technology Specialist; Andy Codd, College & Career Specialist and Deb
 Bruns, STEM Coordinator. Students have learned about careers in computer programming,
 electronics, telecommunications installation, and solar energy while completing projects that

- include wiring sockets & switches, installing cable, making music by programming and wiring a cardboard guitar, and assembling a solar PV system to produce and store energy
- Industry tours in areas of hospitality, manufacturing, and agricultural industry sectors.
- Youth in Transition event at Yolo COE on 2/6. The workshop provided information about serving and advocating for foster youth and homeless youth. Over 80 people attended representing social services, school counselors, attendance liaisons, postsecondary institutions, and community based organizations.
- Hosted industry roundtables in the community focusing on skills gaps and developing short term career technical education programs to meet employer needs.
- Partnership with Sutter COE the Drone Commercial Licensing short term CTE program. The 10week course is open to adults and will prepare them for the state certification required to operate drones for commercial use. The course is offered via distance education. (flyer attached)
- **Upcoming event:** Celebration of Ethnic Studies, March 4th from 8:00 3:00 at Pioneer High School.
- Upcoming event: Second Project SOLAR field trip to Grasslands Regional Park. On March 21, 28 Davis HS students will make a second visit to Grasslands Regional Park to complete a native plant restoration project and learn about the park's unique habitats and ecosystems, including the vernal pools. The students are learning about the park (including the Yolo County solar farm there) in order to teach their peers as part of an alternative energy unit in the Chemistry & the Community classes. (In January the students planted over 100 native plants, toured the solar farm and participated in a learning activity to make connections between solar energy and the many uses of the park.)
- Presentation to the Blue Ribbon Commission regarding Building a Resilient Yolo on Foster Youth
- 2nd Annual African American Student Leadership Conference: 136 youth in attendance, with close to 200 participants, including parents and grandparents (KCRA 3 covered the event)
- "Creating Safe Spaces" (Be the Change Through Unity event) event 30 participants
- Second Chance Through Music grant implementation initiated at Dan Jacobs
- Green Beret, Trino Savala, Jr., guest speaker at Dan Jacobs




Which county are you from? (26 responses)




Have you populated the new SBE – approved LCAP Template and Annual update with last year's approved LCAP information?


Have you been collecting data for analyzing your progress on local and state performance Indicators?




Have you been tracking expenditures on actions and services for 2016-2017? (26 responses)














