3.2. Supervisors of Attendance Certification

Description

Effective January 1, 2019, each district and county office governing board must appoint a Supervisor of Attendance pursuant to Education Code 48240. In accordance with Education Code 48241, no Supervisor of Attendance may be appointed without first having been certified by the County Board of Education to fulfill the role. On September 9, Yolo County Office of Education held the first Supervisor of Attendance training which prepared district identified candidates to perform the duties of the Supervisor of Attendance. Attached to this item is the list of names of candidates who successfully completed the training. These names were brought to the board in October for information. Staff are bringing the list of names back to the board for approval to certify this list as qualified Supervisors of Attendance. Once certified, districts will be notified that their candidates are able to be appointed by their governing boards as their Supervisor of Attendance.

Summary

Hazardous air quality due to area wildfire disasters was the factor in the decision to close all Yolo County Office of Education programs on Friday, November 16, 2018. A letter of support from Dr. Ron Chapman, Yolo County Public Health Officer, was issued on the unanimous decision made by Yolo County Office of Education Superintendent, Dr. Ortiz, along with all Yolo County School District Superintendents. State Superintendent of Public Instruction, Tom Torlakson, also issued a news release in support of school closures.

Once Form J-13A Request for Allowance of Attendance Because of Emergency Conditions is approved by CDE, YCOE is authorized to disregard the closure days in the computation of average daily attendance per Education Code Section 41422 and obtain credit for instructional time for the days and the instructional minutes that would have been regularly offered on those days pursuant to Education Code Section 46200, et seq.

CDE is requesting board approval and signatures of board members on the Affidavit of Governing Board Members page of form J-13A.

At the end of the current school year, June 30, 2020, EPIC will have been in operation five years. Since Charter Schools must be re-evaluated for renewal every five years, EPIC has submitted a Charter Petition for renewal (attached) for the Yolo County Board's consideration.

On November 19, a team from EPIC/GCC will attend the Yolo County Board meeting to present their annual review. EPIC's Charter Petition for renewal is included in the November Board packet as an information item. Presently, YCOE staff and legal counsel are reviewing EPIC's Charter Petition and preparing a redline copy of the petition with recommended revisions. If revisions are necessary, YCOE will be requesting EPIC/GCC make any agreed recommended revisions to their Charter Petition prior to the December 17 Yolo County Board meeting.
