3. 1. Considerations for Dan Jacobs School

Description

Per California Education Code §48645.3, juvenile court schools shall not be closed on any weekday of the calendar year, except those weekdays adopted by the board of education as school holidays or set aside by the board of education for in-service purposes. However, the board of education may close juvenile court schools when it deems such closing is necessary to accommodate contingencies.

Presently, due to the outbreak of the novel coronavirus (COVID-19), the majority of schools in California have closed and the Yolo County Public Health Officer has issued a Shelter in Place Order for Yolo County from March 19 to April 7, unless extended. The Yolo County Shelter In Place Order exempts:

10.f.xii. Educational institutions—including public and private K-12 schools, colleges, and universities—for purposes of facilitating distance learning or performing essential functions, provided that social distancing of six-feet per person is maintained to the greatest extent possible;

As such, our legal counsel has advised that the Yolo County Office of Education (YCOE) Board has the ability to designate juvenile hall as an “essential function,” which can remain open provided YCOE employees are able and willing to continue to staff the classroom, and social distancing of six-feet can be maintained to the greatest extent possible.
