The Brown Act applies when you have a majority of your members present at the same time and same place, to hear, discuss, deliberate, and are regarding the matter of agency business. Goes over the different ways that the Brown Act might apply in certain contexts, for example on Social Media. While members may attend events together it is important not to discuss business agenda items otherwise it might be a violation of the Brown Act. There are different types of meetings. Agendas are required for all meetings and they must be public to everyone. The public has the opportunity to provide general comments where all records and agendas must be made public. Meetings must be in person so that all are able to participate.
